



Background

About CES – The Journey so far

With this background, FICCI contemplated the idea of constituting a platform with an objective to mainstream discussions around Circular Economy in India involving stakeholders across industry, government, civil society and academia, and hosted the first edition of Circular Economy Symposium (CES) in 2017. In continuation, the next edition held in 2018 witnessed showcasing of innovative strategies and practices that will enable the Indian Economy to achieve sustainable economic growth through circularity.

CES 2018 also witnessed the release of FICCI-Accenture theme paper on 'Accelerating India's Circular Economy Shift: A Half trillion USD opportunity - Future proofing growth in a resource scarce world' (http://ficci.in/spdocument/22977/FICCI-Circular-Economy.pdf). The highlight of the report - Circular business growth models could spell gains of up to \$697bn in India by 2030. It gave a deep insight into how circular economy models can radically help Indian businesses in creating sustainable value.

At the crux of it, it was concluded that to mainstream circularity, there is a need to create an ecosystem that fosters knowledge sharing and rewards the spirit of innovation.
